School Uniform Policy

1 Introduction

1.1 It is our policy that all children should wear school uniform when attending school, or when participating in a school-organised event outside normal school hours.

1.2 Our **School Uniform** consists of the following

- Purple sweatshirt or cardigan
- Gold polo t-shirt
- Black or grey trousers or skirt / pinafore (no leggings or jogging bottoms)
- Gold or purple gingham school dress.
- Plimsolls (for indoor use only)
- School Book Bag or Back Pack



PE Kit

- Purple or gold round neck t-shirt
- Purple shorts
- Purple PE hoody
- Plain black joggers
- PE bag
- Trainers
- Socks



2 Aims and objectives

- 2.1 Our policy is based on the notion that a school uniform:
 - promotes a sense of pride in the school;
 - engenders a feeling of community and belonging;
 - is practical and smart;
 - identifies the children with the school;
 - is not distracting in class (as fashion clothes might be);
 - makes children feel equal to their peers in terms of appearance;
 - is regarded as suitable, and good value for money, by most parents and carers;
 - has been designed with health and safety in mind.

4 Extreme haircuts

4.1 The school does not permit children to have haircuts that could serve as a distraction to other children.

5 Footwear

- 5.1 The school wants all children to grow into healthy adults. We believe that it is dangerous for children to wear shoes with platform soles or high heels in school, so we do not allow this. Please think about sensible footwear for your child and also weather conditions.
- 5.2 **Indoor Shoes –** we ask parents to provide indoor plimsolls to be kept in school for your child to wear inside the school building. We send indoor shoes home at the end of each term for you to check wear and size.

6 The Role of Parents and Carers

- 6.1 We ask all parents and carers who send their children to our school to support the school uniform policy. We believe that parents and carers have a duty to send their children to school correctly dressed and ready for their daily schoolwork. Parents and carers should ensure that their child has the correct uniform, and that it is clean and in good repair.
- 6.2 If any parent would like the school to modify the uniform policy, they should make representation, in the first instance, to the Headteacher. The school welcomes children from all backgrounds and faith communities. If there are serious reasons, e.g. religious objections or medical objections as to why parents and carers want their child to wear clothes that differ from the school uniform, the school will look sympathetically at such requests. Similarly, should an item of school uniform prove problematic for a pupil with disabilities, then parents and carers are invited to draw this to the attention of the Headteacher. The school will not treat pupils with disabilities unfavourably.

7 The Role of Academy Councillors

- 7.1 The Academy Council supports the Headteacher in implementing the school uniform policy. It considers all representations from parents and carers regarding this policy, and liaises with the Headteacher to ensure that the policy is implemented fairly and with sensitivity.
- 7.2 It is the Academy Councillors responsibility to ensure that the school uniform meets all national regulations concerning equal opportunities, and that our school uniform policy is consistent with our policy on equal opportunities.
- 7.3 Academy Councillors ensure that the school uniform policy helps children to dress sensibly, in clothing that is hardwearing, safe and practical.

8 Monitoring and Review

- 8.1 When monitoring this policy, through its committee work, the Academy Council will:
 - seek the views of parents and carers, to be sure that they agree with the policy, and support it;
 - consider with the Headteacher any requests from parents or carers for individual children to have special dispensations;
 - require the Headteacher to report to the Academy Council on the way in which the policy is being implemented.
- 8.2 This policy will be reviewed by the Academy Council every three years, or earlier if considered necessary.
